# 2024 State Open of Virginia Independence Golf Club | Midlothian, Va

## Notice to Players

*(This information supplements the Championship entry, Standard Local Rules and Terms of Competition)*



**Tee Markers:** All play will be from the Independence tee markers.

**Format:** 54-holes of stroke play. The field will be cut to the low 60 players and ties following round two. A tie for first place will be decided by a sudden-death playoff that will commence as soon as possible after completion of play.

**Cart/Transportation Policy:** Players may have a caddie and caddies may ride in carts only if there is a seat available. Spectators (outside agencies) may ride in carts if there is a seat available. The Committee may modify this policy at any time during the competition. Two carts will be provided for a group of three players. One cart will be provided for a group of two.

**Faint Painted lines:** All faint painted lines (penalty area, ground under repair, etc.) on the course have no status for this competition. Players must use the newly painted lines for all relief situations.

**Out of Bounds:** Out of bounds is defined by the line between the course-side points, at ground level, of white stakes, and fence posts.

### Obstructions:

- Immovable obstructions adjacent to each other, including but not limited to sprinkler heads near putting greens, etc., are considered to be a single obstruction. Consult a referee with questions.
- Temporary Immovable Obstructions: Model Local Rule F-23 is in effect. Temporary immovable obstructions include air-circulation fans near putting greens, all starting and scoring tents, sponsor signs and camera towers. Relief may be taken on either side of the TIO.
- Hole #13: the railroad ties/bulkhead right of the putting green is an immovable obstruction. Free relief is available under Rule 16.1b.
- Stones adjacent to cart paths are part of the cart path.

**Fresh sod:** Fresh sod on the course is either ground under repair or, if adjacent to an immovable obstruction (e.g. a cart paths), a continuation of that obstruction. Consult a referee with questions.

**Dropping Zones - Hole #12 & #18:** If a ball is in or it is known or virtually certain that a ball that has not been found is in the penalty area, the player may proceed under Rule 17.1d; or, as an additional option, drop a ball, under penalty of one stroke, in the painted dropping zone provided.

- #12 dropping zone is located at front right of the fairway.
- #18 dropping zone is located on a forward tee.

**Pace of Play:** See the championship website for the pace of play policy.
