NOTICE TO PLAYERS

(This information supplements the Championship entry and the Standard Local Rules and Terms of Competition for 2026 USGA Championships)

TEE MARKERS:

- Senior Championship: **GREEN VSGA** tee markers.
- Super Senior Championship: **WHITE VSGA** tee markers.

FORMAT: Singles match play. If a match is tied after 18 holes, the match will return to hole #1. The round is extended until a hole is won.

PLAYOFF/TIES: Players tied for the last spot for either Championship flight must be present for a hole-by-hole playoff. Ties for the last spot in all other flights will be settled by a match of cards. Ties for seeding in all flights will be settled by a random method.

CADDIES/TRANSPORTATION: Players may have a caddie, and caddies may ride in carts only if there is a seat available. Spectators (outside agencies) may ride in carts if there is a seat available. No additional carts will be given for caddies/spectators.

OUT OF BOUNDS: *Holes #1, 3, 4, 5, 6, 7, 8, 15 and 16* –In addition to the line between the course-side points, at ground level, of white stakes and fence posts, out of bounds is also defined by this course side edge of all public roads. A ball which comes to rest on or across a public road defined as out of bounds is out of bounds even though it may lie on another part of the course.

OBSTRUCTIONS: All walking trails are played as obstructions. Players may take relief, without penalty.

ABNORMAL COURSE CONDITIONS – Ground Under Repair: The downed trees to the left of Hole #10 and behind Hole #11 green are considered ground under repair. Free relief is allowed under Rule 16.1d

IMMOVABLE OBSTRUCTIONS:

- Immovable Obstructions Close to Putting Green: MLR F-5.2 is in effect. The player may take relief under Rule 16.1b if an Immovable Obstruction is on the line of play and is within two club-lengths of the Putting Green and within two club-lengths of the ball. **Relief under this Local Rule is only allowed when both the ball and the Immovable Obstruction lie in an area cut to fairway height or less.**
- Immovable Obstructions within or adjacent to each other, including but not limited to sprinkler heads near putting greens, are considered to be a single obstruction. Consult a referee with questions.
