

# U.S. Senior Women's Open Qualifying James River Country Club July 10, 2025

### **NOTICE TO PLAYERS**

(This information supplements the Championship entry and the Standard Local Rules and Terms of Competition for 2025 USGA Championships)

**TEE MARKERS/FORMAT:** All play will be from the **USGA BLUE** tee markers. Qualifying and alternate spots will be determined over 18 holes of stroke play. Two (2) qualifying and two (2) alternate spots are available. A playoff for the final spot(s) and alternate spots will take place shortly after the last group finishes.

**TRANSPORTATION:** Local Rule as prescribed in Section 8 of the Committee Procedures is in effect. Model Local Rule G-6: Players must walk at all times during the round. Caddies may ride in golf carts.

**OUT OF BOUNDS:** In addition to the line between the course-side points, at ground level, of white stakes and fence posts, Out of Bounds is also defined by the course side edge of public roads. A ball which comes to rest completely on or across a public road is out of bounds even though it may lie on another part of the course. On holes #2 and #4, the course-side edge of the rocks surrounding the tennis facility define out of bounds.

### **DROPPING ZONE:**

### Hole #2 (This is the only dropping zone in use for this competition)

If a ball is in or it is known or virtually certain that a ball that has not been found is in the yellow penalty area, the player may: proceed under Rule 17.1d; or as an additional option, drop the original ball or another ball, under penalty of one stroke, in the Dropping Zone, located next to the cart path before crossing the bridge.

NO PLAY ZONES: Flowerbeds with white stakes with blue tops are No Play Zones. Players must take relief under Rule 16.1b.

**TEMPORARY IMMOVABLE OBSTRUCTIONS:** Model Local Rule F-23 is in effect. Temporary Immovable Obstructions (TIOs) include aircirculation fans near putting greens and all starting and scoring tents. Relief procedure may be taken on either side of the TIO.

**WRONG PUTTING GREEN:** The nursery behind #13 green is a wrong putting green. Players MUST take relief in accordance with Rule 13.1f.

### **IMMOVABLE OBSTRUCTIONS:**

- Immovable obstructions adjacent to cart paths are played as a continuation of the cart path.
- Immovable Obstructions Close to Putting Green: Model Local Rule F-5.2 is in effect. The player may take relief under Rule 16.1b if an immovable obstruction is on the line of play and is within two club-lengths of the putting green and within two club-lengths of the ball. Relief under this Local Rule is only allowed when both the ball and immovable obstruction lie in an area cut to fairway height or less. There is no relief under this Local Rule if the player chooses a line of play that is clearly unreasonable.
- Immovable Obstructions within or adjacent to each other, including but not limited to sprinkler heads near putting greens, are considered to be a single obstruction. Consult a referee with questions.
- Relief for Ball in Penalty Area: Relief under Model Local Rule F-24 may be available for interference of an immovable obstruction (sprinkler head, drain pipe, etc.) within one club-length of the edge of a penalty area, but only when the ball touches or lies on the obstruction or the obstruction interferes with the area of intended swing. Consult a referee with questions


