

19th Senior Open of Virginia Willow Oakes Country Club September 9-10, 2024

Notice to Players

(This information supplements the Championship entry, Standard Local Rules and Terms of Competition)

Tee Markers: All play will be from Willow Oaks tee markers.

Format: 36-holes of stroke play.

Ties: A tie for first place will be decided by a sudden-death playoff that will commence as soon as possible after completion of play.

Pace of Play: See the championship website for the pace of play policy and penalties. Allotted times are printed on scorecards.

Cart/Transportation Policy: Players may have a caddie and caddies may ride in carts only if there is a seat available. Spectators (outside agencies) may ride in carts if there is a seat available. The Committee may modify this policy at any time during the competition. Two carts will be provided for a group of three players. One cart will be provided for a group of two.

Dropping Zone: Hole #7 – If it is known or virtually certain that a ball that has not been found is in the penalty area, the player may, as an additional option to Rule 17.1d, drop a ball in the dropping zone provided on the 71 yard tee.

There are no other dropping zones used for this competition.

Out of Bounds: Out of bounds is defined by the line between the course-side points, at ground level, of white stakes and fence posts.

Obstructions:

- On hole #16, the restroom and adjacent area encircled with white paint is considered to be a continuation of the cart path.
- Immovable obstructions adjacent to each other, including but not limited to sprinkler heads near putting greens, etc., are considered to be a single obstruction.
- Immovable Obstructions Close to Putting Green: Model Local Rule F-5.2 is in effect. The player may take relief under Rule 16.1b if an immovable obstruction is on the line of play and is within two club-lengths of the Putting Green and within two club-lengths of the ball. Relief under this Local Rule is only allowed when both the ball and the Immovable Obstruction lie in an area cut to fairway height or less. There is no relief under this Local Rule if the player chooses a line of play that is clearly unreasonable.
- Model Local Rule F-23 is in effect for greenside fans. Relief procedure may be taken on either side of the TIO.

Faded Paint Lines: Disregard fainted red lines.

Nursery: The turf nursery behind #16 green is a wrong putting green. Players must take free relief (Rule 13.1f).

Scoring Areas: Official scorecards will be distributed on the starting holes and players and markers must certify scores by signing the scorecard in the scoring tents on hole #9 or #18. The digital scorecard used via the app is the unofficial scorecard. The official scorecard is the paper scorecard which needs to be verified in the scroring area.
